Dear Mr. Hasbrouck:

I am writing to inform you that your FOIA request, 2018-SP-01, will be granted in part. We had previously granted you a waiver of fees for processing your request, so no fees will be assessed.

You requested two kinds of documents: (1) records of meetings of a quorum of the Commission before May 4 (your request date), and (2) plans for meetings of the Commission after May 4. Eight meetings with a quorum of the Commissioners occurred before May 4, 2018. Currently, there are eight meetings scheduled for after May 4, which the Commission expects to be attended by a quorum of Commissioners. Additionally, there are three meetings planned in 2018 for groups of the Commissioners when a quorum will not be present. While meetings will likely occur in 2019, there are currently no records that schedule, outline or address those potential meetings. Below is a list of responsive records that were developed in relation to both time periods described above. I have organized them by meeting to facilitate your review, and the attached zipped files were also organized in this manner. If you have any questions about these records or the FOIA process in general, please contact our FOIA Public Liaison, Cristina Flores, at <u>Cristina.Flores@inspire2serve.gov</u>.

Some of the documents you requested were provided by other Federal agencies. Under our regulations, we are required to consult with those agencies before releasing the documents. We are still waiting approval to release the documents highlighted in green. Additionally, the size and format of the audio files for the public meetings are large enough that they cannot be shared via email. I am in the process of reformatting those files, but I expect the process to be time-intensive and, ultimately, they will have to be mailed to you. They are also highlighted in green below to note that they have not yet been released. We expect to release additional record to you by July 2, 2018.

Finally, a number of the documents that were responsive to your request are exempt from FOIA disclosure. I have highlighted them in yellow on the list for your reference. Most of the documents are subject to FOIA exemption 5—documents that contain interagency or interagency information that would be normally privileged in the civil discovery context. When another exemption was relied upon, I have noted it in parenthesis. If you would like to appeal this partial denial of your request, you must send a written request appealing the decision within 90 days of the date of this notice. The appeal request should be clearly marked with the words "FOIA Appeal" and may be sent to the Commission's email, FOIA@inspire2serve.gov; the Commission's website, www.inspire2serve.gov; or to FOIA Appeals, National Commission on Military, National, and Public Service, 2530, Suite 1000, Box No. 63, Arlington, VA 22202.
