## **FOIA REQUEST**

Dear FOIA Officer:

This is a request pursuant to the Freedom of Information Act, 5 U.S.C. § 552.

I request access to and copies of any and all of the following records that have not previously been disclosed to me, or that have not previously been disclosed in the form and format requested, in response to my FOIA requests 2018-SP-01, 2018-SP-03, 2019-CP-01, 2019-SP-01, or 2020-SP-08:

(1) Any records of meetings (by whatever name they may be described) or in-person, telephonic, or online gatherings of two or more members of the Commission, including any entries in paper or electronic calendars, diaries, or scheduling systems, agendas, minutes, "memoranda for the record", motions or proposals, votes, decisions (whether by vote, consensus, unanimous consent, "without objection", decision of the Chair, or otherwise), documents or electronic presentations or files distributed or shown to the Commission, transcripts, audio and/or video recordings, records that classified information was to be discussed, or records of any objections made by member(s) of the Commission to allowing members of the public access to any such meeting;

- (2) Any documents, files, or other records incorporated by reference in any decision of the Commission, including but not limited to the entirety of any item approved or disapproved by the Commission, the entirety of any item included in a "consent calendar" or otherwise approved or disapproved *en bloc*, and, recursively, the entirety of any item incorporated by reference in an item incorporated by reference. If, for example, the Commission has determined, by vote or otherwise, to approve or disapprove Plan X, Report Y, or Schedule Z, than the entirety of Plan X, Report Y, or Schedule Z, and any items incorporated by reference in it, is responsive to this request;
- (3) Any records of responses to the request for comments by the Commission, "Request for Information on Improving the Military Selective Service Process and Increasing Participation in Military, National, and Public Service" (NCMNPS Docket No. 05–2018–01, 83 *Federal Register* 7080-7081, 16 February 2018) and/or "Notice of Extension To Comment Period" (83 *Federal Register* 17573, 20 April 2018), and any similar comments received by the Commission after the expiration of the comment period specified in the "Notice of Extension To Comment Period", in any form or format and submitted by any means, including but not limited to:
- (A) All records of submissions through the form on the Commission Web site at <a href="https://inspire2serve.gov/content/share-your-thoughts">https://inspire2serve.gov/content/share-your-thoughts</a>>, including but not limited to any records of the contents, dates, and times of submissions and the IP addresses from which each was submitted, including any records of such submissions in the form first received by the Commission (*e.g.* as stored on the Web server or transmitted electronically by the server to the Commission);
  - (B) All records of comments received by the Commission by mail;
- (C) All records of comments received by the Commission by e-mail, including attachments, at <<u>info@inspire2serve.gov</u>> or <<u>national.commission.on.service.info@mail.mil</u>>;
- (D) All records of comments received by e-mail, including attachments, at any other e-mail address at which comments to the Commission have been accepted, including the raw "message source" files as received and stored on mail servers or on backup or archival storage devices or media;
- (E) All records (including any submission, transcript, summary, "memorandum for the record", or audio or video recording) of verbal, written, or electronic comments to the Commission, to one or more members of the Commission in their capacity as employees of the Commission, to one or more other members of the Commission's staff, or to any contractor or sub-contractor of the Commission, at any public or private meeting, briefing, "listening session", site visit, or other event;
- (F) All records of written or electronic submissions including but not limited to "comment cards", written testimony, statements for the record, slides, or electronic presentations, presented by any third party to the Commission or to any member of the Commission, its staff, its contractors or subcontractors, or other personnel involved in organizing, hosting, or facilitating any public or private Commission or Commission staff or contractor event, meeting, briefing, or site visit;
- (G) All records of any comments received by any member, staff person, contractor, or sub-contractor of the Commission and forwarded to the Commission as a whole, to all members of the Commission, or to the custodian of responses to the Commission's request for comments;

- (H) Any summary, log, tally sheet, database, spreadsheet, count, statistical or other analysis, categorization, or other report or record aggregated or derived from such records;
- (I) All records of participation or attendance at meetings or events with the Commission or with one or more members of the Commission, including but not limited to all entries in any printed or electronic calendar of the Commission as a whole, any committee or subcommittee or other subgroup of the Commission, and any member of the Commission; any record of the names, titles, and/or affiliations of in-person or remote participants, observers, or attendees at any meeting with one or more members of the Commission; sign-in sheets; Eventbrite or other registration records; invitation, RSVP, confirmation, or attendance lists or records of speakers, panelists, representatives of the news media, or other participants, observers, or attendees; and any list, database, spreadsheet, summary, statistical analysis, or other report or record aggregated or derived from such records;
- (J) Any other record deemed by the Commission to be part of the administrative record of the Commission's "Request for Information" and "Notice of Extension To Comment Period" or its consideration of action based in whole or in part on those notices and the responses thereto;
- (4) All records of written, verbal, or recorded speeches, statements, articles, or presentations given by any member or members of the commission to any persons or publications other than officers or staff of Federal agencies, including but not limited to any submitted or published text, speaking notes, transcripts, audio or video recordings, slides, captions, PowerPoint files, or other records.
- (5) Any records of or pertaining to any possible destruction or deletion of Commission records, transfer of Commission records to the National Archives and Records Administration (NARA), or handling of FOIA requests on or after any such transfer and/or the expiration of the Commission's statutory mandate; any agreement, memorandum of understanding, plan or work, or assignment or responsibility for such activities; and any communications between the Commission and NARA.
- (6) The entirety of any document or electronic file containing any records responsive to any portion of the request described in clauses 1-5 above (so that no portion of any document or file containing any responsive portions should be withheld as "unresponsive").
- (7) Any and all records of internal metadata contained in files responsive to any portion of the request described in clauses 1-6 above.
- (8) Any and all records of filesystem metadata pertaining to files responsive to any portion of the request described in clauses 1-6 above, including but not limited to any records of the filename of each responsive digital record, as it was found on a Commission or contractor workstation, server, storage device, or media; the size of each such file in bytes, KB, MB, or GB; the name or other label or identifier of the workstation, server, storage device, or media on which the file was found; the path to the file in the filesystem on which it was found; and the file date(s) as recorded in the file, in that filesystem, and/or in any label(s) on physical devices or storage media.

I request that all responsive records be provided in text-searchable electronic form. With respect to any records held in electronic form, I request that each such record be provided in the form of a

discrete file with the same name and file format as the file is held by or on behalf of the Commission, as a complete bitwise digital copy of the original word processor files, PDF files, or other electronic files, including any file headers, embedded metadata, and all other file content.

For example, if records of responsive e-mail messages are held in the form of ".eml" files, I request that each such file be produced in the form of a ".eml" file with the same filename and format. Similarly, if responsive records of e-mail mailboxes are held in the form of ".mbx" files, I request that each such file be produced in the form of a ".mbx" file with the same filename and format.

I request that any responsive records of e-mail messages be produced in the form and format of the raw "message source" files, including full addresses and all headers and attachments, as those message source files are held on mail servers or backup or archival digital storage media.

I specifically request that you not create new documents or files in response to this request, not create "documents" such as page-view images or print views from digital records, and not substitute such newly-created "documents", images, or views for requested records held by you as digital files.

If all or any part of this request or searches for responsive records are referred or delegated to other agencies, contractors, offices, or staff, I request that any referral, delegation, or search tasking instructions specifically include my request with respect to the form in which records are to be produced, so that records are not inadvertently converted to, or produced in, other forms or formats.

If you believe that you could respond to this request more quickly if responsive records are produced in a different form, please call me immediately at +1-415-824-0214 to discuss your proposed form of production and possible modification of this request to expedite your response.

As a representative of the news media I am only required to pay for the direct cost of duplication after the first 100 pages of paper records, or cost equivalent for copies of electronic records. Through this request, I am gathering information on policies, procedures, and practices that is of current interest to the public as part of widespread public interest in the activities of the Commission and the exceptionally controversial subjects of the draft, Selective Service, and compulsory service.

I am an award-winning freelance journalist, and the publisher of an informational Web site at <a href="https://resisters.info">https://resisters.info</a>> which is one of the most comprehensive and widely consulted sources of news, analysis, and background and reference information – including information obtained from the Commission in response to my previous FOIA requests, and reporting, analysis, and commentary based on this information and other sources – about the Commission and the issues of the draft, draft registration, compulsory "service", and Selective Service. The information obtained in response to this request will be made available to the public through publication on the Web, along with reporting, analysis, and commentary informed by the records released in response to this request.

Please waive any applicable fees. Release of the information is in the public interest because it will contribute significantly to public understanding of government operations and activities.

The public interest in access to information concerning the meetings of the Commission has been explicitly recognized by votes of Congress and of the Commission itself.

The statute establishing the Commission provides that, "Each meeting of the Commission shall be held in public unless any member objects or classified information is to be considered." While this provision allows Commission meetings or portions thereof to be closed in some cases, it creates an unambiguous, explicit statutory presumption that all Commission meetings shall be open to the public.

The Commission itself has decided that, "Minutes shall be made available to the public on the Commission's website to the extent such minutes or portions thereof would be releasable under the Freedom of Information Act." The Commission's decision that minutes of its meetings "shall be made available to the public on the Commission's website" to the extent releasable under FOIA is clear evidence of the Commission's recognition of the public interest in access to this information.

The withholding of records of the Commission's pre-decisional discussions pursuant to claims of deliberative process privilege makes the release of records of the Commission's post-decisional and therefore unprivileged discussions and activities especially important to public understanding of how the Commission, its members, staff, and contractors have interpreted and explained its decisions, to whom they have communicated about those decisions, and what they have said and have been told.

I have no commercial interest in this information. My reporting on this issue, while carried out in my capacity as a professional journalist, has been unpaid and not undertaken for profit.

If this request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions. I will also expect you to release all segregable portions of otherwise exempt material. I, of course, reserve the right to appeal your decision to withhold any information, to denv a waiver of fees, or to deny expedited processing.

Please respond as soon as possible to confirm your receipt of this request and to advise the reference number assigned to this request and the expected date of completion of Commission action with respect to this request. I look forward to your complete reply within 20 work days, as the FOIA statute and the Commission's FOIA regulations require.

Timely processing of this request is especially important because, as you know, the Commission's statutory mandate destroyed or deleted while this advised that they are subject to immediately by telephone or e-r

ate expires 20 September 2020. No potentially responsive records may be request is pending, and the recipient of Commission records must be pending FOIA requests. To avoid unnecessary delays, please contact mes-mail should you have any questions regarding this request.
